CRITERIA FOR HAIRDRESSING AND BARBERING

- For the Hairdressing qualification, hold the New Zealand Certificate in Hairdressing (Professional Stylist) (Level 4) [Ref: 2413]; the National Certificate in Hairdressing (Professional Stylist) [Ref: 0022]; a Trade Certificate in Hairdressing, or equivalent; or a qualification in advance of these; and/or working towards a hairdressing qualification at Level 5
- For the Barbering qualification, hold the New Zealand Certificate in Commercial Barbering (Level 4) [Ref: 2115]; the National Certificate in Barbering [Ref: O418]; a Trade Certificate in Barbering; or equivalent; or a qualification in advance of these.
- 3 years' experience in industry post qualification of which one year must be 12 months immediately preceding the first selection and appointment
- · Are credited with unit standards 4098 and 11552, or are able to demonstrate equivalent knowledge and skills;
- Are credited with or are working towards a teaching qualification of a minimum level 4; Plus, have attained unit 21204.

OR

Or are enrolled in a programme leading to award the New Zealand Certificate in Adult Literacy and Numeracy Education (vocational/workplace) (level 5) or are able to demonstrate equivalent knowledge and skills.

Are credited with or are working towards **New Zealand Certificate in Adult and Tertiary Teaching Level 5 Qualification** that has embedded literacy and numeracy included in the qualification (I.e. Unit 29623 and Unit 29625) or equivalent knowledge.

CRITERIA FOR BEAUTY THERAPY

The applicant organisation must have policies and procedures to ensure that staff involved in teaching and/or assessment will have attained:

- A recognised qualification in beauty services, whether a National Certificate or an equivalent International Qualification
- · Are credited with unit standards 4098 and 11552, or are able to demonstrate equivalent skills and knowledge

The applicant organisations appointment policies must ensure that tutors/assessors have suitable industry, technical and commercial skills: these skills could be gained, for example, through two years of recent and consecutive practice in industry.

Applicant organisations must have policies and procedures to ensure that tutors and assessors keep up-to-date with current beauty services practice.
